The field inspection will begin at the head of the Saroni Canal, and end at the bottom of the Saroni Canal. There will be stops along the Canal at various locations, including locations for future laser leveling and/or measuring devices. The field inspection will proceed as follows:

- A. Begin field inspection at automatic headgates just downstream of the diversion works in Hoye Canyon;
- B. Move from automatic headgates downstream to those portions of the Saroni Canal in Hoye Canyon which are concrete, or asphalt lined, and where flood overpasses are located:
- C. Move from Hoye Canyon portion of the Saroni Canal to the Wellington Foothills portion, with stops at flood overpasses and areas of prior canal breaks;
- D. Move from Wellington Foothills portion of the Saroni Canal across the Wellington Cut-Off through Canal Road to the existing Long Crested Weir;
- E. Move from Long Crested Weir section across State Highway 338 to view previously laser leveled section of the Canal and the Desert Creek Flood Overpass; and
- F. Move from Desert Creek Flood Overpass Area of the Saroni Canal downstream to Lateral A and Lateral B, where the Field Inspection will end and the Board will reassemble in the parking lot of the Smith Valley Fire Protection District Fire House, 1 Hardie Lane, Smith, Nevada 89430.
- 5. Reassemble in Smith Valley Fire Protection District Fire House Parking Lot, and Discuss Field Inspection Observations
